

**DISTRICT GOVERNOR- ELECT
SPECIAL PLANNING SESSION
Friday, May 19, 2017
Great Wolf Lodge, Traverse City**

The special meeting of the District Governor's Elect was called to order at 1:40 p.m. by Council Chair-Elect Peggy Allen. MOTION: Gingerich, Bullington, to approve the proposed agenda of the May 19 meeting. Motion carried.

REPORTS:

Centennial Celebration Committee – PDG Diane Wehby, Chair

The celebration continues into 2018, giving Lions plenty of opportunity to participate in the Centennial Service Challenge. To date, over 1,000,000 people have been served. The focus continues to be on the four areas of service: Protecting our Environment, Relieving Hunger, Sharing the Vision and Engaging our Youth. Two new areas of service have been added: Pediatric Cancer and Diabetes.

The importance of electronic data reporting was covered by PDG Diane. Three years ago, 38% of clubs reported club activities on-line. That percentage has increased to 65%! Reports need to be provided to LCI on a regular basis. PDG Diane can assist any club needing direction with on-line reporting.

There is a 14% increase in clubs who have qualified for the 4-Diamond banner patch.

Make plans at the club level to increase awareness of Pediatric Cancer and Diabetes using the tools provided on LCIs website.

GMT Report – Lion Lula Gardfrey, Chair

The focus this year is to work together towards accomplishing our goals. Lion Lula asked that Club Health Assessment Reports from each district be sent to her. A training meeting will be held in the near future for all GMT District Coordinators and will be an important first-step in planning for the year. The date will be announced and the location will be at the state office in Lansing. Future meetings will be held in January and May.

GLT Report – PDG Jeff Mayuiers, Chair

Training for VDGs will continue to be held on the Friday of the Council of Governors meeting, beginning with the first meeting on August 4 at the Crowne Plaza, Grand Rapids.

All 1st and 2nd VDGs are invited to attend the training sessions. A schedule was provided for each session topic to be covered during training. PDG Jeff is working with PID Brian Sheehan and DGE Terry Treppa to create a topic on “the cost of moving up.” This will allow future leaders a glimpse into the expense-side of becoming a DG.

Global Service is a new team position which will become part of GLT/GMT. The position description has not been released by LCI at this time, but DGEs will conduct GST interviews in preparation of the 2017 -2018 year.

GLOBAL SERVICE TEAM INTERVIEWS

DGE John Bingham, Jr. asked the DGEs their opinion on allowing a fourth candidate for the position of GST to be interviewed with the other three candidates.

2019 MD 11 State Convention Report – PDG Bob Sturgis, Chair

The Holiday Inn Gateway Center, site of the 2018 MD 11 Convention, affords the perfect opportunity due to abundant space and a Courtyard by Marriott Hotel on-property. With a few of the Districts turning toward one-day “drive-in” conventions, this might be an alternate solution.

For 44 years, Winter Camp for the Blind has provided a mid-winter camp experience for blind and visually impaired adults. Due to a critical lack of funding, camp may not be able to continue on the tradition so many have come to enjoy. A nominal fee is charged to the camper, but the bulk of the financial support comes from the Parade of Checks donations from **MD 11-B1** only.
